

Tillain Cup '09

The winners will receive the Perpetual Trophy donated by Eddie Tillain of Railway Union C.C.

Regulations (for rounds other than the final)

1. Competition is for teams in the Senior 2 and Senior 3 Leagues or as decided by the Junior Branch Committee.
2. Eligibility of players is on the basis of the current league starting list. However unstarred players from the team above are not eligible. Any player who plays in two or more 20-20 Alan Murray Cup matches is not eligible, except with the specific permission of the Junior Branch Committee. Note also Paragraph 4:4 of the general playing regulations, regarding players not available on a regular basis.
3. Starting time 6.00 p.m. or by agreement of the captains, final 5.00 p.m..
4. The Home Team is responsible for confirming the fixture.
5. Matches should be played on the dates shown or as soon as possible thereafter if the home teams ground is not free on that date. If the home team cannot provide a ground before the due date of the next round, they must concede home advantage.
6. League or Cup matches in progress take precedence over Tillain Cup matches.
7. Each innings will consist of a maximum of 20 six ball overs.
8. No bowler may bowl more than 5 overs. Fielding restrictions as in Senior 2/3 league and cup competitions apply. Where officially appointed umpires are present the one-day wide law applies.
9. Higher runs scored wins. In the event of runs scored being level, the team taking the greater number of wickets wins. If these are also equal, the runs scored after 10 overs will decide the winner regardless of the number of wickets down. If runs scored at this point are equal, wickets down will decide. If none of these resolve the matter, the game should be replayed at the reverse venue provided the competition schedule allows.
10. Where a match commences and is interrupted by weather, it shall continue on the next night that the ground is available (i.e. without cancelling any other competitive match under LCU aegis). If the first innings has not been completed when play is suspended, the captains may agree to a complete restart which should take place on the next available night as above. If the home team's ground is not available to complete the match in line with the competition schedule, the matter shall be referred to the Junior Branch Committee who may order that the game be restarted on the reverse ground.
11. Results to be notified on result cards in the normal way to Michael Sharp, Hon. Secretary of the Junior Branch, ensuring that they are received before the due date for the next round.

Regulations for Finals

The regulations for earlier rounds apply in each final except for those relating to starting times and continuations. The following additional regulations apply.

1. Starting Times/Order of matches
Whelan Cup 11.00 am
YMCA Salver 2.00 pm
Tillain Cup 5.00 pm

This order will be maintained even if starts are delayed.

2. Weather delayed starts – Any of the finals may start at any time up to 5.30 pm.
3. Interruptions after commencement of match – A match once commenced shall continue after interruptions until finished or until in the opinion of the umpires conditions are such that play for the day has to be suspended.
3. Continuations – Where play is suspended after the completion of the first innings, it shall continue on the same ground on a date and at a time to be decided by the Junior Branch Committee in consultation with the host club and the finalists.
4. New starts – Where no start is possible or play is suspended before completion of the first innings, the match will be played on a date and at a venue decided by the Junior Branch Committee.
5. A match manager for the day will be appointed by the Junior Branch Committee. S/he will have authority to vary any of the above regulations on the day should s/he feel that this is appropriate. Any such variation will be done after consultation with the team captains involved, the officially appointed umpires and the host club.
